### **KINGDOM COMMUNITY FUNDING INITIATIVE**

As of 2018, The Church at Victorville (TCVI) Constitution has been fully accepted by the U.S. Government and the American business community as a legal and lawful ‘non-501(c)3’ unincorporated ‘church’ association.

The legitimacy and good standing of TCVI is established with the IRS, Bank of America and PayPal; and most recently, listed in Google Search and analytics. All funds donated to, or otherwise received by TCVI and its ‘para-church’ ministries, are both tax deductible and tax-exempt, according to the U.S. Constitution.

In America, President Trump has now removed by Executive Order, the free speech restrictions on 501(c)3 churches previously imposed by the IRS. This action has shifted U.S. socio-politics toward a renewed recognition of the need to honor and enforce the First Amendment rights of all churches and other ‘religious’ organizations.

**As an outreach of TCVI, the Kingdom of Yisrael Community Network (KYCN) hereby agrees to appoint a mutually selected representative and/or legal counsel of the ‘Ministry of Divine Justice’ and/or ‘A Better World’ to oversee the TCVI PayPal account as an additional administrator, linked to the TCVI-KYCN Bank of America savings account. In this manner, TCVI-KYCN PayPal transactions may be provably transparent – periodically**

**monitored and subjected to the scrutiny of American Constitutional law, and to the Divine standard of the Torah; and thereby, operated and maintained to the satisfaction of all participating individuals and organizations.**

TCVI-KYCN is convinced that doing business in this Divinely inspired fashion will assure all relevant parties of the trustworthiness of the TCVI PayPal business account, as a safe and secure vehicle to facilitate the proper care of our beloved family in eretz Yisrael, westward in Eden, and in America.

In addition, we believe this approach to funding our Kingdom communities will provide a legal and lawful basis for related non-profit organizations to expand their community development activities beyond the regulatory constraints of 501(c)3 and its governmental counterparts in Israel and Africa.
