## A R O Y A L D E C R E E

Elder Yashah, to the Sons of Dawid, Yahudah and Yerushalayim; and to all Yahudah; and to Ephraim and the Greater Commonwealth of Yisrael, Greetings.

My fellow countrymen, for as long as most of us can remember, the Hebrew Yisraelite Movement has been deeply divided over the 'four-hundred years prophecy,' recorded in Genesis 15. And as we all know, the 2019 end-date is based on the official 1619 historical marker of the introduction of chattel slavery into America. The prophecy reveals that after a four-hundred-year servitude, Abraham's seed shall come out of great affliction "...with great *substance*." And now, the official marker of 1619 has been codified in the recent landmark legislation, 'H.R. 1242,' echoing the position of the proponents among us – of which I am one.

My brethren, does this particular prophecy apply to all Yisrael?

As you know, Hebrew Yisraelites were scattered across the length and breadth of the earth, according to the Torah. And surely, the final dispersal of the Kingdom of Yahudah was primarily southward into 'Africa.' And we who were delivered to the Americas – *and to the United States in particular* – have been specifically set apart from the Yahudim remaining in Africa, as well as from Ephraim in America; and also from the children of the Commonwealth at-large. Of course, many of our Hebrew Yisraelite ancestors were living, both free and bond, in the Western

Hemisphere *prior* to 1619. However, 1619 marks the four-hundred-year affliction of Yahudah, beginning at Point Comfort, Virginia; coming directly under the aegis of the revolutionary ‘American Experiment.’ Let it also be known throughout the Commonwealth that Hebrew Yisraelites from the United States of America represent *a specifically set-apart component of the overall Diaspora*; consisting primarily of the ‘first family’ and the ‘nobles’ of the Kingdom of Yahudah; i.e. the inhabitants of Benyamin, Yerushalayim, and the Royal House of Dawid.

So why the United States?

The original underlying intent of the U.S. Constitution was to replicate the Divine preeminence of ancient Yisrael. And this destiny and purpose makes the United States of America totally unique among the nations of the earth. To that extent, the four-hundred-year affliction of ‘Abraham’s seed’ in fact began *under the thirteen British colonies of America* in August 1619, and set in motion a chastisement and processing that remains totally unique among the Diaspora.

(NOTE: The maiden voyage of “The Good Ship Jesus” which marked the introduction of chattel slavery into the Western Hemisphere *at-large*, was to the Spanish stronghold of the Dominican Republic in 1562, some fifty-seven years earlier.)

Finally, my brethren, the four-hundred-years prophecy specifically concerns Abraham’s seed – *singular* – whom the B’rit Khadashah-New Covenant reveals to be Yah’shua/Yahushua/Yahusha/Yashaya/Yahawashi – *The Messiah Himself!* (Gal. 3:16). And therefore, the Genesis 15 prophecy speaks *only* of those Hebrew Yisraelites determined by Abba YAH to be in Ha Mashiach Yah’shua! (Gal. 3:29). SÉLAH.

Clearly, the overwhelming majority of Hebrew Yisraelites in Christ are, and will be, from America. And so shall the Hebrew Yisraelites of Melekh Dawid, Yahudah, Yerushalayim, and Ephraim fulfill the prophecy of Genesis 15 of an end-time mass Exodus of the seed of Abraham to the land of our fathers. Even so, Amen.
